New York State Real Estate Education Foundation 2010 Scholarship Rules and Application

Mission/Purpose

Through its scholarship program, the New York State Real Estate Education Foundation (NYSREEF) aims to raise the level of knowledge, professionalism and client service among those in the real estate profession by encouraging participation in approved courses.

Eligibility

Any individual who has at least one year experience in real estate sales and/or related disciplines, who is licensed and practicing in New York State and who holds primary REALTOR® membership in New York State is eligible. Applicants should:

- Show positive motivation toward real estate education and
- Prove interest in furthering their career in real estate, real estate education or REALTOR® board administration.

Application

___ Applications must be completed and postmarked by August 1, 2010.

___ Two letters of recommendation supporting the applicant must also be postmarked by August 1, 2010.

Recommendations should include one from a broker or manager of the firm with which the applicant is associated; the other from someone else familiar with the applicant professionally (such as a local board officer, a community or civic organization leader or other professional). When a local board staff member is applying, a letter from a local board officer may replace the broker's/manager's letter.

___ Applicants must attach a letter providing information about why this particular scholarship is needed (although scholarship awards are not based on need, you may address any existing financial hardship), plans for use of the scholarship, how it will assist in career development, and future goals relating to the use of the scholarship. A statement of community involvement, local board activities and any other information that might aid in the selection process should be included in the letter.
