## Foundation Goals

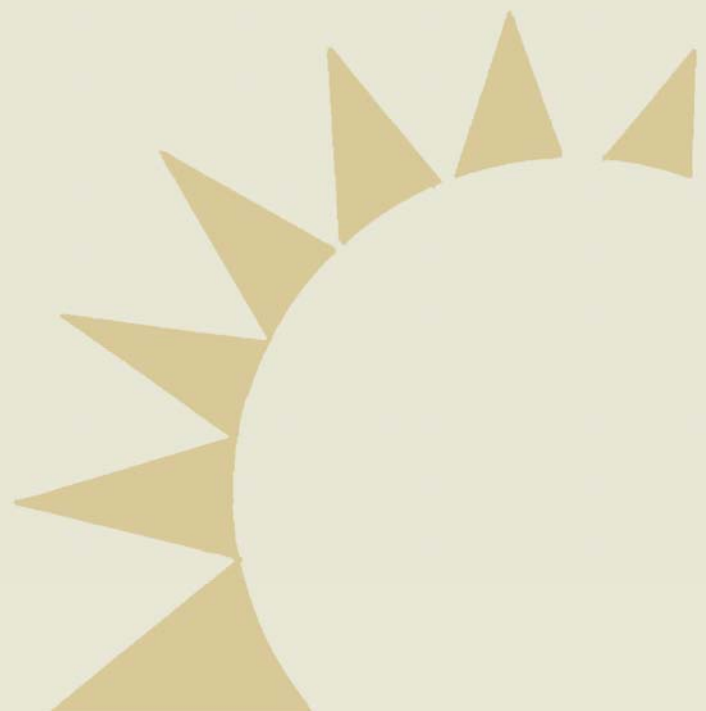
The New York State Real Estate Education Foundation fosters excellence in the real estate industry by providing:
